- (A) On 3 May 2022 the Oil and Gas Authority granted the Carbon Dioxide Appraisal and Storage Licence CS007 to BP Exploration Operating Company Limited and Equinor New Energy Limited ("the Licence");
- (B) The OGA and the Licensee are the current parties to the Licence; and
- (C) The OGA has agreed with the Licensee that the Licence shall be amended as follows.

## NOW THIS DEED WITNESSES THAT:

- With effect on and from the Effective Date, the Licence shall be amended as follows:
  - a) in clause 1(1), delete the words ""Crown Lease" has the meaning given to it in s.18(4) of the Act;";
  - b) in clause 2, delete sub-paragraph (2); and
  - c) in clause 32, delete sub-paragraphs (3)(f) and (3)(g).

This Deed may be executed in any number of counterparts with the same
effect as if the signatures on the counterparts were a single engrossment
thereof PROVIDED THAT this Deed shall not be completed until each party
has signed a counterpart.
